Membership Rules and Regulations Refresher

Family memberships cover up to two (2) adults over the age of 18 living in the same household (Adult Primary Members), with no limit on dependent children under the age of 18. For our purposes, a dependent is a child claimed as a dependent by parent(s) or legal guardian(s) for income tax purposes and lives in the same household. Proof of address may be required.

We understand that families may be blended and living situations can fluctuate for a variety of reasons. In the event another adult (or more than one other adult) resides in the same household/at the same address as the 2 Adult Primary Member(s) on a Family Membership, we will allow additional non-dependent adults living in the same household/at the same address as the Adult Primary Members **to pay \$75 each to join the Family Membership. We WILL require proof of residency**, so we ask that you go ahead and email info@chestnutoaks.org with questions on how to get the proof to us prior to filling out your returning membership form. Please note that failure to pay this fee in the past will not result in a penalty to members, meaning we will not ask for payment for previous years if this fee was not paid. HOWEVER, this fee **will be strictly enforced** this year and in the future, and we ask our members for understanding as we work to ensure we apply our rules and regulations consistently to all members.

The Couples Membership is reserved for true 2 person households. We understand that as children grow older, they may wish to come to the pool less, however, we trust our membership to follow this rule accordingly. Please utilize the Family Membership option if you have children under the age of 18 living at home. We do not allow families utilizing the Couples Membership option to use guest passes for their own children under the age of 18, still living at home.
